Released Writing Prompt, Sample Student Essays, and Scoring Notes

This document contains the following information:

- 1) A released ISASP Writing prompt that was previously administered to students in the relevant grade as part of the ISASP Language/Writing test.
- 2) A copy of the scoring rubric that was used to guide scoring.
- 3) Five samples of actual student responses to the prompt that illustrate a range of scores.
- 4) For each writing sample, a set of scoring notes created at the time of scoring that provide articulations around score point decisions.

Released responses can be examined to better understand how well students are demonstrating writing skills with respect to the four traits that are evaluated as part of the ISASP Writing test. Responses can also be used to gain a better understanding of how ISASP is scored and the application of the rubric to the individual response.

Sample Writing Prompt

The community you live in is considering closing its public library. Community members have provided information about public libraries to people interested in the issue. Read the information. Then, write an essay for the mayor to explain why continuing to provide public libraries for their citizens is important to communities across the United States.

You should use details from the information you are given when you write your explanation. Remember to use your own words. Do not copy. You may also add your own ideas. The Writing Checklist will help you remember important parts of a piece of writing.

Writing Checklist

As you write, remember to:

- Communicate your main ideas clearly.
- Use reasons, details, and examples from the information you are given to develop your writing. You may also add your own ideas.
- Provide clear and logical organization. Include an opening and closing. Use paragraphs and linking words.
- Use precise words and language appropriate for your audience.
- Check your work for correct spelling, grammar, and punctuation.



A History of Public Libraries

There was only one free public library in the United States in 1790. It was in Franklin, Massachusetts. All other "public" libraries were subscription-based. Their use was restricted to members only. Membership required paying dues or buying shares of the library. This cost meant that, generally, many people did not have access to libraries.


The growth of free public libraries occurred in the late 1800s. This was thanks in large part to the efforts of Andrew Carnegie. Carnegie was a wealthy American businessman and public patron. His personal experiences formed his belief that everyone deserved the opportunity to learn and better themselves, regardless of income or background.

Carnegie never had a formal education. Instead, he educated himself by borrowing books from a generous employer's vast personal library. From his first job changing bobbins in a cotton factory, Carnegie rose to become a steel baron. When he sold his company at age 66, he was the richest man in the United States. Yet he never forgot how he had been helped along the way. By the time he died, Carnegie had given away ninety percent of his fortune for charitable reasons.


Some of Carnegie's most enduring donations were libraries. He personally founded 1,689 public libraries in the United States. Many were in small towns for which the library quickly became the center of the community. The architecture of each library was decided by the local community. However, almost all Carnegie libraries shared two design elements in common. Stairs led up to the front entrance to represent elevation through learning. A lamp post stood out front as a symbol of enlightenment.

Today, the total number of public libraries in the United States is 16,536. Anyone can enter and use a public library. All you need is the motivation to enrich yourself. As Carnegie once said, "There is not such a cradle of democracy upon the earth as the Free Public Library...where neither rank, office, nor wealth receives the slightest consideration."
